- OREA's bylaw. Any member rejoining less than 2 years are required to pay OREA dues back to Jan 1 2024 if applicable.
- Dual Member Entry Fee = \$150.00
- Dual Member New Branch Office Entry Fee = \$900.00
- Transfer from another Board/Association = \$150.00
- Member Re-entry Fee (less than 1 year = \$50.00) (1+ years = \$1000.00)
- New Brokerage Application = \$900.00
- Brokerage re-opening after 2 years = \$900.00
- Brokerage/Branch re-opening within 2 years = \$50.00
- New Branch Office for existing Members = \$300.00
